ENTRY PERMIT FORM

Important information – Before starting the application, please read this information and refer the Department of Immigration (DoI) website at doi.gov.bt.

After completing the application, we highly recommend that a copy of this is retained for record purposes.

Who should use this form?

Nationals of India who intend to visit the Kingdom of Bhutan under a non-tourist category.

General conditions

- 1. A national of India seeking entry into the Kingdom of Bhutan shall hold a valid passport. A Voter identity card is accepted in lieu of passport.
- 2. The original passport or voter identity card must be produced in immigration office for issuance of entry permit.
- 3. The entry permit shall be issued at the port of entry.
- 4. If you intend to stay in the Kingdom beyond the approved length of stay, please apply for extension of your entry permit to the Department of Immigration with relevant document.
- 5. A foreigner who has entered as a non-immigrant as per Chapter 5 of the Immigration Act of the Kingdom shall not be eligible to apply for immigrant status or citizenship.

How to apply?

Present the following documents at the immigration counter:

- 1. Original Identity document stated in the sl no. 1 of the general conditions.
- 2. Recommendation from the relevant agency.
